ALL OTHER VENDORS AND SPONSORS SETUP NO EARLIER THAN 7:00 A.M. FRIDAY, SEPTEMBER 27. SETUP MUST BE COMPLETED BY 10:00 A.M. YOU MUST NOTIFY COURTNEY BARTON IN ADVANCE IF YOU NEED ALTERNATE SET-UP TIMES. TEAR DOWN FOR ALL VENDORS WILL NOT BEGIN UNTIL 11:00 P.M. SEPTEMBER 28 AND CAN BE COMPLETED AT 7:00 A.M. SEPTEMBER 29.
